






Seat distribution in HoC





Seat distribution in both houses






Current Abe Cabinet






Approval ratings for PM Abe remain high, and keep growing!

Key legislation for the Extraordinary Diet Session

- Trans-Pacific Partnership (TPP) Approval and Related Bills (承認案・関連法案)
- Consumption Tax Increase Postponement Bill (消費税増税延期法案)
- Supplementary Budget Bill (補正予算)
- Labour Standards Act Amendment Bill (労働基準法改正法案)
- Integrated Resort Promotion Bill (IR推進法案)
- Pension System Reformation and Related Bill (年金制度改革関連法案)
- Bill on Revision of the Punishment of Organised Crime Act (組織的犯罪処罰法改正 法案) (preparation of terrorist acts)
- Imperial House Reform (皇室典範改正) (?)



Work culture reform

- Adapt a a concrete plan to change Japan's work culture by March 2017 to enable more women to join the workforce
- Improve welfare networks (child care and elderly care) to facilitate female participation in the workforce
- Set rules based on the principle of "equal pay for equal work" before the end of the year
- Support elderly seeking re-employment
- Raise the minimum wage
- Introduce system exempting white-collar employees from work-hour regulations
- Renew rules for severance pay
- Review the retirement age (currently at 60)

However:

- Criticism against unpaid overtime work is likely to surface again
- Criticism that severance pay is likely to make it easier for employers to fire their employees is also possible





Second Supplementary Budget (4.1 trillion yen)

- 4.11 trillion yen in total, of which:
 - 711 billion yen for day-care and nursing-care facilities
 - 1.4 trillion yen for post-earthquake restoration and for strengthening disaster emergency response and preparations
 - 1.4 trillion yen for infrastructure development (linear Shinkansen, port infrastructure, agricultural export facilities, etc.)
 - 430 billion yen for emergency response to cope with aftermath of Brexit, and to support small and medium enterprises





Tax reform: BEPS and spousal exemption

- Base erosion and profit shifting (BEPS) measures are likely to be a key part of the 2016 tax reform
- The spousal tax exemption system, which is built on the assumption that only
 the husband is employed, is under discussion. Instead of a current spousal
 exemption, a new "family exemption" (under which both spouses will be
 entitled to a tax deduction, regardless of their employment status or income)
 is likely to be introduced, to act as an incentive for more women to enter the
 workforce.
- Taxation of beer likely to change
- Revision to the Net Operating Loss carry-forward system
- Automotive taxation
- Etc.
